2. Preparation of the list of all households in each district.
Random selection of households in each district.
3. Sampling of respondent in the household based on Kish grid.

Fieldwork Method: Face-to-face interview.

Systematic properties of the sample

1. The bias resulting from the sampling design: in selected households the probability of selection of respondent was 1 / number of adult household members.
2. Due to a response differences the basic socio-demographic characteristics (sex and education) of the sample significantly differ from the population. See tables on the next page.

Weighting:

Total weight is constructed from:

- 1) design weights based on proportion of household sizes
- 2) post-stratification weights based on region, sex, education, age, economical activity, and size of the community.

The weights were derived from data of the Czech Statistical Office issued on 31st December 2000 and 30th June 2001. Method: raking based on loglinear modelling.

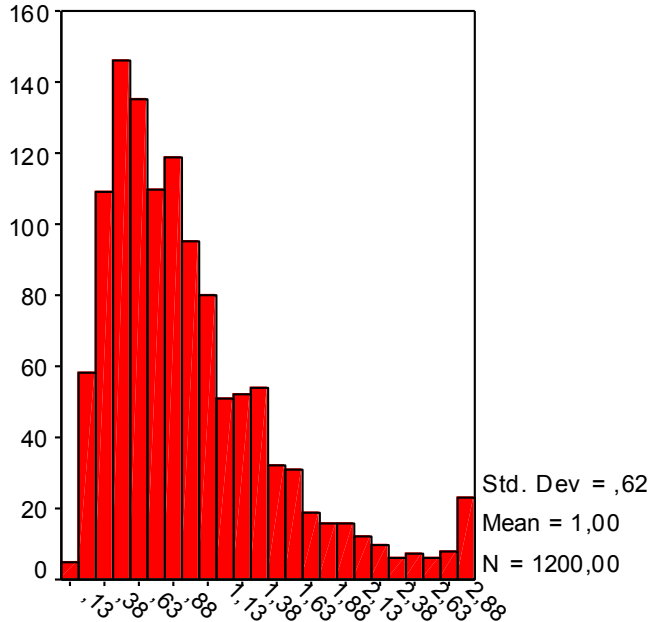
